CALL TO ORDER– 8:32 a.m.

PUBLIC COMMENT: There was no public comment provided at the beginning of the meeting.

A. BOARD GOVERNANCE AND ADMINISTRATION

1. Approval of the July 20-22, 2016 Board meeting minutes: It was moved and seconded that the minutes be approved with corrections.
2. Executive Director Report: C. Dinauer presented this agenda item. She updated the Board on the Governor's Prescription Drug Abuse Summit, the workforce survey for online applications, the Enhanced Nurse Licensure Compact, and staffing.
3. Review and discussion regarding statistics and trends for APRN Audits: C. Prato presented this agenda item. She reviewed the current audit policy and procedure and statistics related to the compliance of APRN audits.
4. Review, discussion, and action regarding proposed APRN postgraduate equivalencies for psychiatric and mental health nurse practitioner policy: F. Olmstead presented this agenda item. He reviewed the history behind this policy and answered Board member questions. The Board suggested this policy be reviewed by the APRN Advisory Committee and stakeholders and revised accordingly. It was moved and seconded the

Board not accept the proposed policy as written. MOTION CARRIED. Following the motion, Cindy Pitlock, NAPNA Legislative Liaison, informed the Board that NAPNA's opinion on this agenda item is that only certified psychiatric mental health nurse practitioners are qualified to release legal holds.

6. Review statistics and trends related to scope of practice inquiries: S. McCord presented this agenda item. He reviewed the new presentation of this item and provided the Board with an update related to scope of practice inquiries.
7. Review and discussion Nurse Licensure Compact Fiscal Note: C. Dinauer presented this agenda item. She reviewed the fiscal impact note as provided by NCSBN for the implementation of the Enhanced Nurse Licensure Compact, which indicates a \$189,000 income loss.
8. Review, discussion, and action regarding July 2017 Board Meeting Date: H. Murphy presented this agenda item. She requested the Board review a date change for the July 2017 Board Meeting due to a meeting space conflict. It was moved and seconded the Board change the July 2017 Board Meeting dates to be July 25-27, 2017. MOTION CARRIED.

She reviewed the history of this agenda item and indicated the liability of having Board Staff review and approve NCLEX study plans. She reviewed the history behind this policy and answered Board member questions. The Board suggested this policy be reviewed by the APRN Advisory Committee and stakeholders and revised accordingly. Following this agenda item, Cindy Pitlock, NAPNA Legislative Liaison, provided comments related to this agenda item and stated that NAPNA wants to be included on this discussion.

It was ordered that these courses must be completed within thirty days or the Respondent's license be suspended without further proceedings and the disciplinary action be permanent and published to all appropriate national data banks. It was further ordered that Respondent pay all fines owed to Boards of Nursing within sixty days or her license be suspended without further proceedings and the disciplinary action be permanent and published to all appropriate national data banks. MOTION CARRIED.

It was further moved and seconded that respondent be reprimanded, fined in the amount of two hundred dollars (\$200), and must take and complete continuing education including thirty (30) hours on Legal Ethics and a four-hour bioterrorism course within thirty days or the license be automatically suspended without further proceedings. It was ordered that the discipline be permanent and published to all appropriate national data banks.

It was ordered that these requirements must be completed prior to the suspension on Respondent's licenses being lifted.

It was moved and seconded that Respondent be reprimanded, fined in the amount of one hundred dollars (\$100), and complete continuing education on critical thinking, patient safety, and the Nevada Nurse Practice Act Course within sixty days or the certificate is automatically suspended without further proceedings and that the discipline be permanent and published to all appropriate national data banks.

Upon review of the evidence submitted at the time of the hearing, it was moved and seconded that discipline previously imposed be removed and Respondent be granted her certificate. MOTION CARRIED.

2. Review, discussion and action regarding Touro University board ordered site survey and approval of teach-out plan: C. Prato presented this agenda item. She provided the Board with an overview of the site survey conducted following the May Board Meeting and stated that Touro University is planning to teach out their program. Representatives from Touro University and C. Prato answered questions and provided history to the Board. Touro University has volunteered to be heard on each agenda until the final teach out of the program. It was moved and seconded that the Board accept the teach out plan and that progress reports of the plan be reported at every Board meeting. MOTION CARRIED.
3. Review, discussion and action regarding Chamberlain College of Nursing admission reports: C. Prato presented this agenda item. She stated that at the March 2016 Board meeting the Board required Chamberlain to submit monthly admissions reports to the Director of Nursing Education. Chamberlain requested that the reports be moved to an eight week cycle to fit their enrollment plan. It was moved and seconded that the Board allow Chamberlain College to report student admission numbers on an eight week basis. MOTION CARRIED.
