#### PUBLIC COMMENT -

- Keith Marcher was present to publically thank the Board for working with him throughout his tenure with the Nevada Attorney General's Office. He complimented the Board on its well run meetings, processes and thoughtful decision making. He also thanked Debra Scott for her hard work with NSBN and wished her well on her retirement.
- Executive Director for the Nevada Nurses Association (NNA), Margaret Curley, was present to provide an update to the Board regarding NNA initiatives. She announced that NNA will be holding its annual holiday dinner on December 6, 2015 and Annual State Board Winter Reception on January 29, 2016. She explained that NNA has created a Long Term Care staffing group to review and propose safe staffing law revisions. She also

congratulated NNA President, Scott Lamprecht, for receiving an award from the International Council of Nurses.

- 3. Progress report on FY 15/16 Goals and Objectives: The Board reviewed the most recent progress related to the achievement of Board goals and objectives.
- 4. Financial statements (quarterly report): D. Estes presented the first quarter of FY 15/16 financial report, answering questions from the Board members.
- 5. Fraud presentation from Emily Tse, Director of Evaluations from International Education Research Foundation: E. Tse provided a detailed presentation to the Board regarding common themes among fraudulent documents submitted to various regulatory Boards for licensure or certification.

All Board members agreed that hiring a consultant would benefit NSBN as this is a huge undertaking. The Board also expressed that the NLC should be reviewed in detail to ensure that its provisions align with our current licensure requirements. The Board agreed that a contract must be established if a consultant is hired and directed staff to research this option further and report the findings at a future Board meeting.
- 8. Review and acceptance of FY 14/15 Audit Report: Beth Kohn-Cole, CPA, Kohn Colodny, LLP, described the audit her firm conducted of the Board's financial statements for the year ended June 30, 2015. She informed the Board that the audit did not identify any deficiencies, commended Dean Estes, the Board's Director of Finance and Technology, and responded to Board member questions.
- 9. Review and discussion of FY 14/15 Annual Report: The Board reviewed the FY 14/15 Annual Report. D. Scott thanked D. Estes for his hard work at compiling the data for this report.
- 10. Review, discussion and action regarding the provision of security at future Board meetings: The Board discussed hiring security for future Board members. All Board members agreed that hiring security would help ensure the Board and public's safety during Board proceedings. published and reported to all appropriate agencies. It was further ordered that should the

applicant reapply within 30 days and the application has no material changes, Board staff may accept the application for further processing. In addition, Applicant must complete Board approved courses on legal ethics, critical thinking, and the Nevada Nurse Practice Act prior to issuance of a certificate and within six months or the application will be denied and that the denial become part of the applicant's permanent record and be published and reported to all appropriate agencies. MOTION CARRIED.

- 8. Ratification of staff denials NRS 632.320 (1)(b) convictions
  - a. Virgil, Thea, CNA applicant: Applicant was present to appeal the staff denial. It was moved and seconded the Board ratify the staff denial of the application for CNA certification for violation of NRS 632.320 (1)(b) criminal conviction and order the denial become part of the applicant's permanent record and be published and reported to all appropriate agencies. It was further ordered that should the applicant complete all court requirements she may reapply and be evaluated by the Professional Evaluations Group, and follow all recommendations. MOTION CARRIED.
- E. EDUCATION
  - Review and discussion regarding the NCLEX first time pass rates for CY 2015: R. Colosimo shared the CY 2015 third quarter NCLEX pass rates highlighting that Nevada's fully approved programs are all performing well. She added that Kaplan's LPN program and Nevada Career Institute (NCI) continue to struggle. Responding to Board member questions, R. Colosimo explained that Kaplan's LPN program and NCI may achieve an 80% NCLEX pass rate but at this time it is not definitive.
  - 2. Review and discussion regarding foreign nursing graduates and course concurrency: R. Colosimo informed the Board that, currently, we do not have the ability to ensure course concurrency for international graduates. She explained that we have contacted the Commission on Graduates of Foreign Nursing Schools (CGFNS), our current credentialing evaluator, to ask if they will be able to provide course concurrency but have not received any information indicating that this is possible. The International Education Research Foundation has informed Board staff that they are able to provide course concurrency. J. Tan confirmed that course concurrency is a requirement in Nevada regulation.
  - 3. Review, discussion and action regarding International Education Research Foundations proposal as a credentialing evaluator: Emily Tse from the International Education Research Foundation (IERF) presented a PowerPoint providing the Board with the history and processes for credential evaluating at IERF. E. Tse explained that the processing fee is similar to our current provider. R. Colosimo added that the definition of concurrency and the list of applicant requirements will be vetted by the Education Advisory Committee and must be approved by Board. E. Tse also explained that IERF will work closely with its nurse consultants and Board staff to ensure that all Nevada requirements are met. M.A. Brown clarified that this procedure will change if Nevada joins the NLC. It was moved and seconded the Board approve International Education Research Foundation as a credential evaluation service provider. MOTION CARRIED.

4. Review, discussion and action regarding Kaplan College, LPN program change in curriculum without Board approval. R. Colosimo informed the Board that while she was reviewing Kaplan's six-month report she discovered that they were using simulation for pediatric clinical. She clarified that the Board had not previously approved this change in Kaplan's curriculum. Program Director of Nursing, Julia Millard was present to address concerns and explained that as soon as R. Colosimo called this to her attention she began correcting this issue. J. Millard

stated that she immediately created a plan to find pediatric clinical placements and clarified that this change was made by the previous program director. Board members expressed frustration with the lack of accountability for the change in the curriculum and directed staff to begin an investigation to determine if a violation of the Nurse Practice Act was committed and by whom. Board members were concerned about how the clinical objectives and outcomes were met. The Board also agreed that there are many outpatient pediatric experiences available for students. It was moved and seconded the Board direct staff to begin an investigation regarding the lack of pediatric clinical placements and to determine if the program is in compliance with all Nevada regulations. MOTION CARRIED.

5. Review, discussion and action regarding Nevada Career Institute request for change in admission requirements and permission to admit students: NCI Las Vegas Director of Nursing, Katherine Cylke and Corporate Director of Nursing, Adnan AlMouazzen were present to address the Board. R. Colosimo explained that the change of admission requirements had been discussed with the Education Advisory Committee (EAC) and the committee suggested various revisions. In addition, NCI is requesting permission to begin admitting students into its program. K. Cylke explained that during her 14-month tenure improvements have been made including, increasing the program's NCLEX pass rates and receiving a positive verbal report from the ACEN site visit. K. Cylke explained that they would like to admit 32 students and reminded the Board that NCI voluntarily halted student admissions. She added that they do not have any students and if they wait until January 2016 to begin admissions the program would not have students for at least five months. R. Colosimo explained that while reviewing the sixmonth report she became concerned about the number of students in remediation. The report showed that 24 students were admitted in cohort 7, but only 6 students graduated. In cohort 8, 24 students were admitted and 4 students graduated and in the last class 32 students were admitted with 13 students graduating. K. Cylke replied that the remediation program was specifically designed for the students for a fee of \$1,500 for the eight weeks. M.A. Brown added that the six-month report also showed a class with 32 students admitted had 25 students withdraw. K. Cylke responded that the information she submitted was not correct. R. Colosimo also informed the Board that EAC was very concerned about NCI admitting all students that applied to the program. Board members agreed that admissions should not be allowed until the 2015 NCLEX first time pass rates were reported and reviewed by the Board. It was moved and seconded the Board continue Nevada Career Institute provisional approval and deny the request for student admissions until the 2015 NCLEX first time pass rates are reviewed. MOTION CARRIED.
