The Board Meeting for the Nevada State Board of Nursing was called to order by Board President, D. McKenzie at 9:01 a.m.

PUBLIC COMMENT: C. Dinauer noted it was APRN Week via the Governor's proclamation; S. VanBeuge received the 2019 AANP Advocate's State Award for Excellence. C. Dinauer congratulated G. Trujillo for completing the CPM Program.

A. BOARD GOVERNANCE AND ADMINISTRATION

- 1. Approval of Board meeting minutes: September 12-13, 2018. Approved under the consent agenda.
- 2. Executive Director Report. C. Dinauer provided the process board members will follow when they receive a call to meeting (CTM) from NCSBN. Please forward emails from NSCBN regarding a CTM received to the Executive Assistant.
- 3. Review, discussion, and action regarding FY 18/19 Goals and Objectives. Approved under the consent agenda.

- 4. Review, discussion, and action regarding Board Member Elections. Board President D. McKenzie called for nominations for President. Board Member O'Driscoll nominated D. McKenzie for another term. D. McKenzie accepted the nomination. The Board voted unanimously for D. McKenzie to serve another term as President. Board President Deena McKenzie called for nominations for Vice President. Board Member Watts nominated S. VanBeuge. S. VanBeuge accepted the nomination. The Board voted unanimously for S. VanBeuge to serve another term as Vice President. Board President D. McKenzie called for nominations for Secretary. Board Member VanBeuge nominated J. Watts for another term. J. Watts accepted the nomination. The Board voted unanimously for J. Watts to serve another term as Secretary.
- 5. Review and discussion regarding Open Meeting Law (OML) as it pertains to a quorum of board members attending a professional conference or social gathering. Board Member VanBuege presented her question regarding the OML. Board Counsel clarified OML limitations.
- 6. Review, discussion, and action regarding EBSCO Health 2019 renewal. C. Dinauer presented this item and explained this very valuable tool NSBN utilizes on a daily basis. It was moved and seconded to accept the three year EBSCO Health 2019 Renewal. MOTION CARRIED.
- 7. Review and discussion regarding Conference and Training Report by staff. Approved under the consent agenda.
- 8. Review and discussion regarding Conference and Training Report by Board Members. C. Dinauer presented this item. This agenda item will be on future agendas for Board Members to report their experience and what they learned at conferences which they have attended.
- 9. Review and discussion of FY 18/19 Q1 Financials. V. Alvarez presented the FY 18/19 Q1 Financials.
- 10. Review and discussion regarding the Enhanced Nursing Licensure Compact. M. Hillerby provided the most recent update on the eNLC. M. Hillerby, D. Dinauer, K. Arguello and F. Olmstead traveled to Chicago in September to meet with NCSBN to get more information on the Compact. Our team received some new ideas, such as reaching out to various military for their support. M. Hillerby has been meeting with various legislators regarding the concerns the unions have. M. Hillerby is trying to forge a path to get the Compact enacted into law. M. Hillerby is working with William McCurdy and has a meeting planned. C. Dinauer has been doing a lot of work on the workforce side – reaching out to state agencies, etc. We also have a plan to identify supporters of the Compact. C. Dinauer mentioned there will be an Occupational Licensing Meeting later this month and there will be a discussion regarding compacts. C. Dinauer also met with the chief nurse at the National Guard of Nevada regarding nurses in the military. C. Dinauer will be connecting with them. C. Dinauer and F. Olmstead recently went to Las Vegas and spoke to nurses through the March of Dimes and gave a presentation on the Compact to help get the word out.
- 11. Review, discussion and possible action regarding proposed revisions to the Violations of Monitoring and/or Probations Terms and Conditions policy. S McCord presented this item. It was moved and seconded to accept the updated Violations of Monitoring and/or Probations Terms and Conditions policy. MOTION CARRIED.
- 12. Review and discussion of statistics and trends related to scope of practice inquiries. S. McCord presented the statistics and trends related to scope of practice inquiries.

- 13. Review, discussion, and possible action regarding FY 17/18 Audit. V. Alvarez and V. David presented the Independent Auditor's Report. V. David reported a clean and unmodified opinion. We are in compliance with all laws of Nevada. Report on internal control was also an unmodified opinion, no material weaknesses, and no internal control issues. Auditor's comments included there were no difficulties, staff was a joy to work with, and information requested was provided quickly. It was moved and seconded to accept the audit. MOTION CARRIED.
- 14. Review and discussion regarding ORBS Update. K. Arguello presented the updates on ORBS. Some of the highlights include: almost 25,000 nurses have created accounts, and a one day turn around for applications, documents, and communication. ORBS FAQs created and posted to our website.
- 15. Review and discussion regarding NSBN Webex. K. Arguello presented this item. NSBN has its own WebEx account which will maximize efficiency, cut down on travel, and facilitate easy teleconferencing.

Prato states the program has improved dramatically. Milan accepted the Board's recommendation to do a student satisfaction survey and have made adjustments to staff based upon that survey. It was further ordered that Respondent's license be reprimanded and placed on probation for a period of one-year and that the disciplinary action become a part of the Respondent's permanent record and be published and reported to all agencies.
