## NEVADA STATE BOARD OF NURSING NURSING PRACTICE ADVISORY OPINION

Requested by: Nursing Practice Advisory Committee

Date: December, 1993

It is the opinion of the Nevada State Board of Nursing that vaginal speculum examination and specimen collection/evaluation be included within the scope of practice for Registered Nurses who meet the requirements of NAC 632.225, provided:

- 1) procedure is performed for routine STD screening and or routine pelvic/pap evaluation;
- 2) the collection of routine specimens, routine exams and screenings are service that are an extension to a physician or APN but must be under the direct supervision of a physician or APN;
- 3) appropriate formal specialized training and education (e.g. CDC training) is completed;
- 4) treatment prescription by authorized practitioner via standardized policy/procedure is followed; and
- 5) competency evaluations by APN, M.D. and/or employer are established. Documentation must be maintained in the nurse's personnel file.
